### International Interreligious Affairs

#### <u>January</u>

While I did not travel abroad in January, the month was full of speaking engagements in Israel to foreign and local groups. These included:-

- The historic mission of Indonesian Muslim leaders to Israel brought here by AIJAC
- The mission of <u>the Japanese Institute for Strategic Leadership</u> (ISL) of some fifty Japanese CEOs

- An interfaith panel for <u>AJC's Project Interchange Leadership mission</u> took place on which I joined Bishop William Shomali of Jerusalem and the Muslim Khadi (head of the court) of Jerusalem, Iyad Zahalka.
- The <u>bilateral commission of the State of Israel and the Holy See</u> held its latest talks on resolving the outstanding legal and fiscal issues (still on the agenda since the signing of the Fundamental Agreement in 1993 of which I was part of the negotiating team)

#### **February**

<u>The Vatican, Feb. 1-3</u>. The second meeting of the Pontifical Academy of Sciences and Social Sciences' Ethics in Action Council (established together with the World Conference of Religions for peace and Columbia University's Earth Institute) held inside the Vatican, focused on "The Pursuit of Peace". I gave two presentations, one on "Positive Peace in the Jewish Tradition" and the other on "the Role of Religions in Conflict and Conflict resolution".

<u>Vienna, Feb. 6-8.</u> The KAICIID Advisory Board and Board of Directors meetings in which I participated and spoke were scheduled to take place during the U.N. week of Interfaith Harmony for which KAICIID held a special program at the Albert Schweitzer Institute focusing on the challenges of absorbing and integrating refugees in Europe today, attended by members of the diplomatic corps, religious leaders and the members of the Advisory Forum and Board.
